### **Focusing session origins**

- Donaldson's Program Theory-Driven Evaluation Science: Strategies and Applications (2007)
- The construction of a plausible and sensible model of how a program is supposed to work (Bickman, 1987)
- Need to develop program impact theories independently of, and isolated from, the empirical evaluation design

## Focusing session value proposition

- Create common understanding and build trust
- Make program theory explicit and testable
- Provide framework for data collection and analysis
- Frame evaluation questions

### Creating a community of learning

- What are the 3 attributes you would like to contribute to this evaluation study?
- How do we want to conduct the evaluation as co-creators of knowledge?
- What kind of community of learning do we want to create?

# Program mapping

- Start with the long-term outcomes and work backwards (intermediate, then short-term)
- Make sure stakeholders understand the difference between an action and a change
- Work in small groups and then put the changes up on the wall and draw the arrows with the whole group

# Question formulation and prioritization

- If you could get a sound answer to a question about your program that would help improve its impact, what would it be?
- What are the questions you want and need answers to? What is important to measure in this program? What are your knowledge needs?
- What are the 3 to 5 questions that you want to get answered in the next X months?
- Working together toward shared vision to create together that which we cannot create alone
- Contributing to solving complex problems = improving the quality of life on the plane
